# Critical Race and Feminist Legal Theory

LPS 135 (CRN 6572) Spring 2013 Prof. Cramer

Critical, Critical Race, and Feminist Legal Theories represent new (from the 1970s until the contemporary period) ways of thinking about and understanding the role of law in our lives. This course will introduce students to the foundational work in these realms as well as newer extensions of the theory via critical disability, queer, and intersectional analyses. Students will be required to engage in service learning, experiential learning, and/or community involvement through this course.

# Responsibilities and Policies {redacted}

### Grading

Your grade in this course will be based on four (1 page single-spaced) reader response papers, three longer papers (5 - 12 pages), an in-class open book final examination, and your participation.

#### Response Papers

During our first and second class periods, you will choose four readings to write a brief response paper for. The response paper must: summarize the argument made in the reading, explain the methodology used by the author(s), and analyze the understanding of law and legal consciousness inherent in the author(s) argument. It may also take an opinion regarding the usefulness of the author(s)' understanding, methodology, and argument. The response paper should be *no longer than 1.5 typed*, *single-spaced pages*. Each response paper is worth 50 possible points (200 total).

#### Longer Papers

You will write three longer papers in this class – one personal narrative, one analysis of a text (court case, song, movie, photo), and one based on the learning you achieve through an experiential component (discussed in class). The rubrics for those three papers will be posted early in the semester, and you are encouraged to hand in drafts for review. I will accept drafts until April 19<sup>th</sup>; you may revise until you are happy with the grade – or until May 7<sup>th</sup> (whichever comes first). Final versions of all three papers are due on May 7<sup>th</sup>. Each paper is worth 100 points, for a total of 300 points possible.

#### Final Exam

There will be an open note, in-class final, on May 15<sup>th</sup>. It will be comprised of two essay questions that will ask you to synthesize our work over the course of the semester. Each of the two essays on the final is worth 100 points, for a total of 200 points possible on the final.

#### **Participation**

This is a class will operate as a seminar: you will learn from the readings, certainly, and from me – but also from each other. I expect every one to be prepared when they come to class, and to share their preparation with each other in respectful dialogue. You will be able to earn up to 100 "participation points" in this class. Many of these points will be based on your in-class work; you earn them primarily by being actively engaged in the material we cover this semester. Active and productive engagement will earn participation points; if you are consistently and obviously unprepared to participate in class discussion, your participation score will suffer. I encourage you to bring relevant and useful information to class: when you do, I will grant you participation credit. As well, some of the things that would usually be "extra credit" will, in this class, count as "participation" in the course. These include your attendance at relevant lectures, exhibits, rallies, and other events, as well as screening films, voting, and other activities. Opportunities for earning participation credit in this way will be posted frequently on Black Board. Your assignments and all grading rubrics, some of our course readings, and some additional/optional handouts and participation points information, will be posted to Black Board each week. In some cases, this will be your only access to that information.
